

# Leo Express Global a.s. and Leo Express s.r.o. Tariff for Carriage of Passengers and Baggage

effective from July 1st, 2022

This Tariff was authorized by Leo Express Global a.s. Board of Executives and Leo Express s.r.o. Director on June 30<sup>th</sup>, 2022.



### Definition of abbreviations and terms for purposes of these Conditions

- LE Leo Express Global a.s., with registered seat at Řehořova 908/4, 130 00 Prague 3 Žižkov, Czech Republic, IČ 290 16 002, eventually Leo Express s.r.o., with registered seat at Řehořova 908/4, 130 00 Prague 3 – Žižkov, Czech Republic, IČ 066 61 572,
- **operator** LE or other entity, which LE assigns to exercise rights and duties under the carriage contract concluded with a Passenger,
- **reservation system** LE online reservation system for booking and purchasing tickets available on the web page www.leoexpress.com,
- **Tariff** a valid Leo Express Global a.s. and Leo Express s.r.o. Tariff for carriage of Passengers and baggage in the public passenger railway transport,
- **ZTP** a person with severe health disability
- **ZTP/P** a person with severe health disability requiring special assistance
- ISIC ISIC card or ISIC Scholar
- **fare** a price for carriage of the Passenger from a Departure station to a Destination station according to the valid tariff,
- basic (full) fare a price for carriage of Passenger without any price discount
- **special fare** a price for carriage of Passenger who shall be entitled to the discount from the basic fare
- **promo fare** a special price for basic fare tickets purchased online, the promo fare is always marked in the reservation system
- **fare certificate** a document proving the conclusion of a contract of carriage and rights resulting from such a contract in the course of the execution of the contract, fare certificate is in the rest of the document also referred to as a ticket,
- a ticket with an assigned seat a document proving the legitimacy of a Passenger's claim to a specific seat in a specific train connection and in a specific vehicle, the seat reservation is a part of the train ticket,
- **departure station** a train station, in which the Passenger boards the vehicle of the operator and which is specified on the corresponding ticket,
- authorized person LE steward, LE driver or another person authorized to issue instructions and orders to Passengers, who carries an operator's service identification card,
- Contract of Carriage a contract for transporting passengers, in which the operator pledges to transport passenger from the departure station to the destination station and the Passenger pledges to pay the fare for this carriage,
- vehicle a bus or a train with a visible inscription Leo Express,
- **destination station** a train station, in which the Passenger deboards the vehicle of the operator and which is specified on the corresponding ticket,
- **first+ Class** a travelling class, which is in the case of transport performed directly by LE, is commercially called Premium (labelled on the vehicle 1+)
- **first Class** a travelling class, which is in the case of transport performed directly by LE, is commercially called Business and Economy Plus (labelled on the vehicle 1)
- second Class a travelling class, which is in the case of the carriage operated directly by LE commercially called Economy (labelled on the vehicle 2),
- Contact e-mail info@le.cz is intended for communication in Czech, Slovak and English language and info@leoexpress.pl is intended for communication in Polish, Ukrainian and English language for connections passing through the area of Poland.



# **1. Introductory Provisions**

- (1) LE issues this Tariff in compliance with a valid and effective price regulation of the Ministry of Finance of the Czech Republic.
- (2) This Tariff is in compliance with Act no. 266/1994 Coll., on railways, as amended, with Act no. 111/1994 Coll., on road transport, as amended, with Public Notice of the Ministry of Transport of the Czech Republic no. 175/2000 Coll., on the transport code for public rail and road passenger transport, with Regulation (EU) No. 181/2011 of the European Parliament and of the Council of 16 February 2011 concerning the rights of passengers in bus and coach transport and amending Regulation (EC) No. 2006/2004, with Regulation (EC) no. 1371/2007 of the European Parliament and of the Council on rail passengers' rights and obligations, and with Uniform Rules concerning the Contract of International Carriage of Passengers by Rail (CIV) Appendix A to The Convention concerning International Carriage by Rail (COTIF) of 9<sup>th</sup> May 1980 (the convention was published in the Czech Republic in the Collection of International Agreements by Public Notice of Ministry of Foreign Affairs in Act no. 49/2006 Coll.)
- (3) Regarding transport on the territory of the Slovak Republic, this Tariff is in compliance with Act no. 514/2009 Coll., on Railway Transport, as amended, with Act no. 513/2009 Coll., on Railway, as amended, and with Act no. 56/2012 Coll., on Road Transport, as amended.
- (4) Regarding transport on the territory of the Poland, this Tariff is in compliance with Act of 15 November 1984 r. Transport Law (consolidated text: Polish Journal of 2017, No. 1983), Regulation of the Minister of Infrastructure of 20 January 2005 on the method of determining of determining additional personal transport charges for the carriage of accompanying items and animals, as well as the amount of handling fees (Polish Journal of Laws of 2005, No. 14, item 117), Regulation of the Minister of Transport and Construction of 23 February 2006 on the determination of the status of consignments and the complaint procedure (Polish Journal of Laws of 2006, No. 38, item 266) and Regulation of the Minister of Infrastructure of 23 November 2004 on the order regulations binding on railway area, on trains and other railway vehicles (consolidated text: Polish Journal of Laws of 2015, No. 50).
- (5) The prices are stated including added tax, unless stated otherwise.
- (6) LE publishes Tariff in compliance with Section 13, Article 2 of Act no. 526/1990 Coll., on prices, as amended, price list and conditions for its usage on websitewww.leoexpress.com. A brief abstract may be published in the LE ticket offices. In the territory of the Slovak Republic Tariff, is published in compliance with Section 8, Article 3 of Act no. 513/2009 Coll., on railways carriage, as amended.
- (7) All the relationships resulting from this Tariff shall be governed in compliance with the laws of the Czech Republic (decisive law). A competent court for dispute settlements from these legal relationships is the Czech court.
- (8) Tariff applies on domestic and international public passenger railway transport operated by LE on the territory of the Czech Republic, Slovak Republic and Poland.
- (9) To exclude any potential doubts, LE reminds that LE does not provide public passenger railway transport within the scope of fulfilling obligations arising from a public services contract in passenger transport.



# 2. Price for Carriage

- (1) The basic fare is stated in the reservation system, which is the LE reservation system for reservations and sales of tickets available on the website <u>www.leoexpress.com</u>.
- (2) The LE reservation system chooses the most favourable fare according to information entered by Passenger during research.
- (3) The maximum amount of tickets on one purchase is 40. In case the Passenger wish to buy more tickets, he shall contact LE Sales department through contact form on website <u>www.leoexpress.com</u> or on e-mail address <u>obchod@le.cz</u> / <u>info@leoexpress.pl</u>, where the Passenger obtains an individual price offer.

### 2.1 Fare Types

- (1) **Basic (full) fare** is a price for carriage of Passenger without any price discount.
- (2) **Special fare** is a price for carriage of Passenger who shall be entitled to the discount from the basic fare. The amount, type and conditions of provided discounts are stated hereinafter in this document.
- (3) **Promo fare** is a special price of tickets, which are available only for adults. The quantity of tickets, the time to finish the purchase and the choice of seats is limited. Promo tickets are available only when purchased online (reservation system or phone app), where they are marked. It is not possible to combine Promo fare with any other discounts, unless stated otherwise.
- (4) Corporate and Corporate Family is program, designed for companies on the basic of concluded approvals with the conditions of the Corporate and Corporate Family program, which regulate cashback or negotiate a turnover discount on fares.

# 3. Tarify a slevy Tariffs and discounts

### 3.1 Discounts valid on the territory of the Czech Republic

- (1) Special fare is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic. The price is regulated by these means only for railway carriage on the territory of the Czech Republic. In case of international carriage, the price is regulated on the part of the carriage operated on the territory of the Czech Republic.
- (2) Special fare is deducted from basic fare, provided that entitlement for special fare have Persons specified by this Tariff and regulated by price regulation of the Ministry of Finance of the Czech Republic.
- (3) For achieving a higher discount, a special fare **shall not be combined with another special fare**, if it is not particularly stated otherwise.
- (4) The Passenger is entitled to the special fare and other special commercial discounts, if he can prove by defined means the entitlement. The Passenger is obliged to prove the entitlement during the whole carriage, unless stated otherwise. In case he is not able to prove the entitlement, even after a call from the LE Authorized Person, Passenger is obliged to pay the difference between the basic and provided special fare and always from Departure Station to the Destination Station.
- (5) If the seat reserved for Passenger with a special fare remains unoccupied after 15 minutes since the departure of the vehicle from Departure Station stated on the ticket, the Passenger traveling with a common ticket is obliged to pay the price of the ticket up to the amount of the basic fare. If the extra charge for the unoccupied seat is not paid off, the



entitlement for the reserved seat expires. For this purpose, the seat is not considered to be occupied if the Passenger places a part of the clothing or hand luggage on the seat.

(6) The entitlement for a special fare is based on passenger's age on a day of boarding the Vehicle. The special fare is granted until the day before the 15<sup>th</sup> birthday, 18<sup>th</sup> birthday or 26<sup>th</sup> regarding paragraphs 3.1.1. and 3.1.2. of the Tariff.

#### 3.1.1 Children and Juniors

- (1) The Fare for Children and Juniors is:
  - a) discount 50 % of the basic fare for carriage of Passengers between the age of 6 to 17 (incl.), this special fare shall be applicable only for the ride in the 2<sup>nd</sup> class
  - b) discount 100 % of the basic fare for children between the age of 0 and 5 (incl.), this fare shall be applicable in **all the classes.**
- (2) The Fare for Children and Juniors is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic.
- (3) Further, the commercial discount of 25 % is provided for carriage of Passengers between the age of 6 to 17 (incl.), the discount shall be applicable only for the ride in the 1<sup>st</sup> class and the 1<sup>st</sup>+ class
- (4) Passengers over 10 years old with a valid ticket are entitled to the free transfer of unlimited children aged 0-5 (incl.).
- (5) The passenger over 15 years old is obliged to prove himself with a valid identification card with a photography, name, surname and date of birth. The entitlement can be also proved by a pupil's card containing the formalities required by the existing legislation or by the student's ISIC card.
- (6) If the seat reserved for Passenger traveling with a child remains unoccupied after 15 minutes since the departure of the vehicle from Departure Station stated on the ticket, the accompanying person is obliged to pay the price of the ticket up to the amount of the basic fare. If the extra charge for the unoccupied seat is not paid off, the entitlement for the reserved seat expires. For this purpose, the seat is not considered to be occupied if the Passenger places a part of the clothing or hand luggage on the seat.

#### 3.1.2 Students

- (1) The Students between the age of 18 to 25 (incl.) are entitled to a discount of 50 % from a basic fare.
- (2) The Student fare shall be applicable only for the ride in **the 2**<sup>nd</sup> **class**.
- (3) The Student fare is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic.
- (4) The Student fare is applicable for Passengers fulfilling compulsory school attendance or systematically preparing for the professional occupation on secondary, higher vocational, special school or university in full-time study form on all schools in the Czech Republic and abroad, where the institution is equal to the secondary schools and universities in the Czech Republic.
- (5) Students prove entitlement for the Student fare by the valid original of:
  - a) **student's identification card** with a current photo, name and surname, birth of date, school name and validity of the identification card (academic year) or
  - b) valid ISIC card (physical or digital form) or ISIC Scholar (the validity of physical card can be only extended by the revalidation mark, we do not accept any other form of the extension).



- (6) LE verifies and sells the **student's identification card** at the LE office immediately if the following information are filled in and approved by school:
  - a) name, surname, date of birth (filled up by the student or his legal representative);
  - b) school name, validity of the identification card, i.e. the school/academic year lasting until 30.9. of the next academic year or until the end of the current academic year, if that occurs later
- (7) LE collects for verification of the student identification card CZK 40 and CZK 3 for selling a blank form.

#### 3.1.3 Seniors older 65 years old

- (1) The amount of the fare discount for seniors older than 65 years old is 50 % from the basic fare.
- (2) The Senior fare is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic. The entitlement for a special fare is based on passenger's age on a day of boarding the Vehicle.
- (3) In order to be entitled to a special fare, the passenger is obliged to present the original of a European Union citizen's card or travel document or other officially issued valid personal identification document containing the photograph, name and surname and date of birth.
- (4) The discount is applicable only for the ride in **the 2**<sup>nd</sup> **class**.

#### 3.1.4 Holder of a third degree disability certificate

- (1) The amount of the fare discount for the holder of a third degree disability card is 50% of the regular fare.
- (2) This is the so-called discounted fare, i.e. the price regulated by the valid and effective Price Assessment of the Ministry of Finance of the Czech Republic.
- (3) In order to claim the discounted fare, the passenger is obliged to present a valid confirmation with a QR code issued by the Czech Social Security Administration in paper or electronic form, which contains their personal data (name, surname, date of birth, validity of the confirmation) and identity card.
- (4) The discount is granted only in **the 2**<sup>nd</sup> **class**.

#### 3.1.5 Person with Disabilities (ZTP and ZTP/P cardholders)

- (1) The amount of the fare discount for persons with disabilities (ZTP and ZTP/P cardholders) is 75 % from the basic fare.
- (2) This fare is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic.
- (3) Special fare for persons with disabilities is applicable for persons to whom are provided social benefits according to specific regulations and **hold valid ZTP or ZTP/P card**, by which they prove their entitlement.
- (4) The special fare for persons with disabilities (ZTP and ZTP/P cardholders) is applicable only for the ride in **the 2<sup>nd</sup> class.** For the ride in higher class, the person with disabilities (ZTP and ZTP/P cardholder) is obliged to pay the basic fare which is higher than the basic fare for the 2<sup>nd</sup> class.
- (5) Person with disabilities (ZTP and ZTP/P cardholder) shall be also entitled to:
  - a) free carriage of his guide in the 2<sup>nd</sup> class;
  - b) free carriage of the wheelchair
  - c) free carriage of the perambulator, if the passenger is ZTP/P cardholder.



#### 3.1.6 Assistance for ZTP/P cardholder

- (1) The amount of the fare discount for guide of ZTP/P cardholder is **100 % from the basic fare**, i.e. free carriage.
- (2) The special fare for assistance for ZTP/P cardholder is applicable only for the ride in the 2<sup>nd</sup> class. For the ride in higher class, the assistance for ZTP/P cardholder is obliged to pay the basic fare which is higher than the basic fare for the 2<sup>nd</sup> class.
- (3) This fare is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic.
- (4) Another ZTP/P cardholder or a child younger than 10 years old cannot be the assistance for ZTP/P cardholder (except for the assistance for person with visual impairment).
- (5) The assistance for person with disabilities with valid ZTP/P (in compliance with Act no. 329/2011 Coll., on provision of social benefits for people with disabilities and on changes of related acts., as amended) is entitled to carriage free of charge and also in case the ZTP/P card holder exercises different fare.
- (6) The person claiming entitlement for carriage free of charge as an Assistance for the ZTP/ P card holder shall not simultaneously claim an entitlement for a carriage free of charge for a person to whom he provides the assistance.
- (7) The Assistance for ZTP/P cardholder with visual impairment may be also guide dog, which is transported in all the classes free of charge.

#### 3.1.6 Parents Visiting Children with Disabilities

- (1) Parents, when visiting children of physically, mentally or sensually handicapped or chronically ill, permanently or long-term (more than 3 months) placed in medical, educational, social facilities, institutions (hereinafter "the Institute") shall be entitled to a special discount of 50 % from the basic fare for the ride in the 2nd class. The purchased ticket is at the same time valid for the return journey if the visit is confirmed by the date of visit, signature and stamp of the institute. Return journey must be taken no later than the day after the visit.
- (2) The parents or legal guardians (hereinafter referred to as the parents) are entitled to a discount of 75 % from the basic fare during the individual journeys for visits to dependent children with physical or mental disabilities or with permanent or long-term (longer than 3 months) chronical illness located in institutes.
- (3) In order to apply the discount, please contact our customer service at info@le.cz.
- (4) This special fare is applicable only for the ride in **the 2<sup>nd</sup> class**.
- (5) This fare is a special fare, it is a price regulated by valid and effective price regulation of Ministry of Finance of the Czech Republic.
- (6) Passenger shall prove the entitlement for the special fare by **submitting for inspection valid identification card issued by the institute**, in which the child is placed and by parent's ID card.
- (7) The special fare is applicable from the train station located closest to the place of permanent residence of parents in terms of location or time to the train station located closest to the address of the institute in the shortest direction or in the shortest time.



#### 3.1.7 Group Discount

- (1) The amount of the fare discount for groups is 20 % from the basic adult fare.
- (2) The group discount is applicable only for the carriage of 4 or more persons.
- (3) In order to fullfill the entitlement conditions for the group discount (at least 4 persons), the persons with other than the adult fare can be included into the number of passengers, however these persons are not entitled to the group discount.
- (4) It is a so-called **commercial discount** provided by the LE operator.
- (5) **The group discount shall not be combined with another discount.** If a passenger is entitled to a group ticket and at the same time is entitled to another discount, the highest discount will be applied.
- (6) The specific number of people which are allowed for transport on one group ticket is always specified on the ticket.
- (7) After purchasing the ticket, it is not possible to change the number of transported Passengers and the group ticket can be **cancelled only as a whole, no later than**
- (8) 24 hours before the regular scheduled departure of the connection. Transaction fee for the cancelation of group ticket is charged in a one-off amount of CZK 30 for the entire ticket.
- (9) The discount is applicable only for the ride in **the 2<sup>nd</sup> class**.
- (10) Group Discount cannot be applied on the tickets purchased on board. Group Discount can only be applied on the tickets purchased at the cashdesk LE, on the website or through the mobile application.

#### 3.1.8 Return ticket

- (1) For purchase of return ticket, 20 % discount is applicable for the return journey (the ticket with the later date of departure) from the basic adult fare.
- (2) The discount is applicable for the ride in all the classes, always for the same class that was purchased for the way there.
- (3) It is a so-called **commercial discount** provided by the LE operator.
- (4) The return ticket shall not be combined with another discount. If a passenger is entitled to a return ticket and at the same time is entitled to another discount, the highest discount will be applied.
- (5) The return journey is a purchase of tickets for one route, where the journeys have opposite directions (the Departure Station of the first ticket is the same as the Destination Station of the second ticket and Destination station of the first ticket is the same one as Departure Station of the second ticket).
- (6) Return ticket cannot be purchased on board. It can only be purchased at the cashdesk, on the website or through the mobile application.
- (7) Time between the dates of departures of both journeys shall not be longer than 30 days.
- (8) The return ticket may be cancelled:
  - a) as a whole (both journeys at once) until the time of scheduled departure of the vehicle from the Departure station with the sooner date of departure (the way there).
  - **b)** only the way back, it is possible to cancel the second journey (the way back), after the first trip is completed (the way there).
  - c) discount for the return ticket cannot be used for group fares, different discounts cannot be combined.



#### 3.1.9 Interrail and Eurail

- (1) The Passenger is entitled to the discount of 100 % with Interrail or Eurail ticket. Interrail and Eurail tickets are only valid for the train connections. It is not possible to use Interrail or Eurail ticket for the buses and minibuses. It is necessary to prove yourself with the Pass and identification card.
- (2) The valid Pass for the 2<sup>nd</sup> Class can be used in the 2<sup>nd</sup> Class.
- (3) The valid Pass for the 1<sup>st</sup> Class can be also used in Business and Economy Plus Class.
- (4) It is necessary to make a reservation, there is no fee for the reservation. It is necessary to state the Interrail / Eurail ticket number.

#### 3.1.10 Others

- (1) To carriage free of charge are entitled:
  - a) employees of the Ministry of Transport and Rail Authority exercising state inspection in the matters of rails in compliance with Act no. 266/1994 Coll., on railways, as amended. Employees of the Ministry of Transport and Rail Authority exercising state inspection in the matters of rails shall submit for inspection the identification card to the LE Authorized person proving the entitlement for exercising the state supervision.
  - **b) policeman in service** in compliance with Section 42 Article 5 of Act no. 273/2008 Coll., on Police of the Czech Republic, as amended.
  - c) other persons based on conditions stated in general legal regulations.

### 3.2 Discounts valid on the territory of the Slovak Republic

#### 3.2.1 Children and Juniors on the territory of the Slovak Republic

- (1) The fare for Children and Juniors is:
  - a) discount 25 % of the basic fare for carriage of passengers between the age of 6 to 17 (incl.), the discount is applicable for the ride in all the classes;
  - b) discount 50 % of the basic fare for carriage of children between the age of 0 to 5 (incl.), the discount is applicable for the ride in all the classes.
- (2) Passengers between the age of 15 to 17 (incl.) are obliged to prove entitlement for a special fare with a valid identification card issued by public authority with the passenger's photo, name, surname and date of birth. The identification card may be issued by the operator after submitting the birth certificate and the photo of passport format for the manipulation fee of CZK 50.
- (3) It is a **so-called commercial discount** provided by the LE operator.
- (4) If the seat reserved for passengers with a child remains unoccupied after 15 minutes since the departure of the train from the departure station stated on the ticket, the supposed escort of the child is obliged to pay the price of the ticket up to the amount of the basic fare.
- (5) Since Leo Express does not provide public railway and road passenger transport under Public Services in Passenger Transport contract, the free transport of children, students, youth and seniors according to the Resolution of Government of the Slovak Republic no. 530 of 22nd October 2014, is not provided in the territory of the Slovak Republic.



#### 3.2.2 Group and return ticket on the territory of the Slovak Republic

(1) On the territory of the Slovak Republic, the group and return ticket discount are applicable according to the articles 3.1.7. and 3.1.8. of LE Tariff.

#### 3.2.3 Special fare on the territory of the Slovak Republic

(1) If the seat reserved for Passenger with a special fare remains unoccupied after 15 minutes since the departure of the vehicle from Departure Station stated on the ticket, the Passenger traveling with a common ticket is obliged to pay the price of the ticket up to the amount of the basic fare. If the extra charge for the unoccupied seat is not paid off, the entitlement for the reserved seat expires. For this purpose, the seat is not considered to be occupied if the Passenger places a part of the clothing or hand luggage on the seat.

#### 3.1.4 Interrail and Eurail

- (1) The Passenger is entitled to the discount of 100 % with Interrail or Eurail ticket. Interrail and Eurail tickets are only valid for the train connections. It is not possible to use Interrail or Eurail ticket for the buses and minibuses. It is necessary to prove yourself with the Pass and identification card.
- (2) The valid Pass for the 2<sup>nd</sup> Class can be used in the 2<sup>nd</sup> Class.
- (3) The valid Pass for the 1<sup>st</sup> Class can be also used in Business and Economy Plus Class.
- (4) It is necessary to make a reservation, there is no fee for the reservation. It is necessary to state the Interrail / Eurail ticket number.

#### 3.1.5 Other discounts on the territory of the Slovak Republic

- (1) To carriage free of charge are entitled:
  - a) Employees of state professional supervision of The Ministry of Transport, Construction and the Transport Authority,
  - b) members of police force.
- (2) To carriage free of charge are also entitled the other persons based on conditions stated in general legal regulations.

### 3.3 Discounts valid on the territory of Poland

#### 3.3.1 Children and Juniors on the territory of Poland

- (1) The fare for Children and Juniors is:
  - a) discount 25 % of the basic fare for carriage of passengers between the age of 6 to 17 (incl.), the discount is applicable for the ride in all the classes;
  - b) discount 50 % of the basic fare for carriage of children between the age of 0 to 5 (incl.), the discount is applicable for the ride in all the classes
- (2) Passengers between the age of 15 to 17 (incl.) are obliged to prove entitlement for a special fare with a valid identification card issued by public authority with the passenger's photo, name, surname and date of birth. The identification card may be issued by the operator after submitting the birth certificate and the photo of passport format for the manipulation fee of CZK 50.
- (3) It is a **so-called commercial discount** provided by the LE operator.
- (4) If the seat reserved for passengers with a child remains unoccupied after 15 minutes since the departure of the train from the departure station stated on the ticket, the supposed escort of the child is obliged to pay the price of the ticket up to the amount of the basic fare.



#### 3.3.2 Group and return ticket on the territory of Poland

- (1) On the territory of Poland, the group and return ticket discounts are applicable according to the articles 3.1.7. and 3.1.8. of LE Tariff.
- (2) The prices are regulated for the section realised on the territory of Poland.

#### 3.3.3 Special fare on the territory of Poland

- (1) The following discounted fare based on Tariff is provided in the territory of the Polish Republic accordingly to the Act no. xx/2017 Coll., paragraph 1983, as amended, to the Act no. 14/2005 Coll., paragraph 117, as amended, to the Act no. 38/2006, paragraph 2066, as amended, to the Act no. xx/2015, paragraph 50, as amended, and to the Act no. xx/2018, paragraph 295, as amended. The price is regulated only for railway and road transport in the territory of the Polish Republic. In case of international transport, the price is regulated for that part of the journey, which takes place in the territory of the Czech Republic.
- (2) If the seat reserved for Passenger with a special fare remains unoccupied after 15 minutes since the departure of the vehicle from Departure Station stated on the ticket, the Passenger traveling with a common ticket is obliged to pay the price of the ticket up to the amount of the basic fare. If the extra charge for the unoccupied seat is not paid off, the entitlement for the reserved seat expires. For this purpose, the seat is not considered to be occupied if the Passenger places a part of the clothing or hand luggage on the seat.

#### 3.3.4 The Persons with Disabilities and Their Assistance

- (1) The discount is applicable only on the territory of Poland and after proving the entitlement with the respective Polish document authorizing the discount.
- (2) The escorts, guardians and the assistance of the persons with disabilities and visual impairment are entitled to the discount of 95 %. The escort may be an adult person or in case of persons with visual impairment, it may be a person older than 13 years old o ran assistance dog.
- (3) Children and adolescents with disabilities up to the age of 24 and students or persons with disabilities up to the age of 26 are entitled to a 78 % discount. The discount is applicable only when traveling from the place of residence or the place of stay to and from:
  - a) nursery school;
  - b) school;
  - c) university;
  - d) nursing centre;
  - e) educational institution;
  - f) special educational centre;
  - g) centre enablingchildren and adolescents to fulfil their educational responsibilities;
  - h) rehabilitation and educational centre;
  - i) social care home;
  - j) support centre;
  - k) medical centre;
  - psychological and pedagogical counselling centre including a specialized counselling centre;

m) rehabilitation stay.

- One of the parents or guardians of children and adolescents with disabilities is entitled to a 78 % discount. The entitlement only applies when traveling in the sections stated under (3).
- (5) A civil blind victim of war conflicts who is recognised as being incapable of self- existing shall be entitled to a 78 % discount,



- (6) Persons with visual impairment who are incapable of self-existing shall be entitled to a 51 % discount. A person with disability in a significant extent and with invalidity of the first group shall be also recognised as being incapable of self-existing (if a decision to be included in the group has not lost its power)
- (7) A civil blind victim of war conflicts who is recognised as being incapable of working shall be entitled to a 37 % discount.
- (8) A blind person who is incapable of self-existing shall be entitled to a 37 % discount.
- (9) A person who is incapable of self-existing except for a blind person shall be entitled to a 37 %. A person with disability in a significant extent and with invalidity of the first group shall be also recognised as being incapable of self-existing (if a decision to be included in the group has not lost its power).

#### 3.3.5 Children

- (1) Children between the age of 0 to 4 shall be entitled to the discount of 100 %.
- (2) Children and Adolescents on the territory of Poland are entitled to a 37 % discount when proving themselves with a respective document in the period from the beginning of compulsory annual pre-school preparation to completion of the grammar school (public or non-public) up to 24 years.
- (3) Children and adolescents up to the age of 18 on the territory of Poland with a respective Polish document entitling to a discount shall be entitled to a 37 % discount in the period of studying Polish, History, Geography, Polish Culture or other subjects taught in Polish in:
  - a) schools operated by social organizations abroad registered in a database maintained by an authorized unit subordinate to the minister responsible for education and training;
  - b) schools operating in the education systems of other countries;
  - c) Polish sections working in schools operating in education systems in other countries;
  - d) in European schools educating in accordance with the Convention defining the Statute of the European Schools of 21st June 1994.

#### 3.3.6 Students

- (1) On the territory of Poland, to a discount of 51 % are entitled (after proving themselves with a respective Polish document):
  - a) students up to 26 years;
  - b) students studying abroad;
  - c) The university students of social services according to the Act of 20 June 1992 on the entitlement to concessionary travel with public means of transport (consolidated text: Polish Journal of Laws of 2018, No. 295) up to the age of 26 years.
  - d) doctoral students up to 35 years.

#### 3.3.7 Adults aged 60 years and older

- (1) On the territory of Poland, to a discount of 37 % to two rides per year are entitled (after proving themselves with a respective Polish document):
  - a) pensioners;
  - b) persons with a sickness pension;
  - c) spouses of persons with a sickness pension who receive family allowances.



#### 3.3.8 Interrail and Eurail

- (1) The Passenger is entitled to the discount of 100 % with Interrail or Eurail ticket. Interrail and Eurail tickets are only valid for the train connections. It is not possible to use Interrail or Eurail ticket for the buses and minibuses. It is necessary to prove yourself with the Pass and identification card.
- (2) The valid Pass for the 2<sup>nd</sup> Class can be used in the 2<sup>nd</sup> Class.
- (3) The valid Pass for the 1<sup>st</sup> Class can be also used in Business and Economy Plus Class.
- (4) It is necessary to make a reservation, there is no fee for the reservation. It is necessary to state the Interrail / Eurail ticket number.

#### 3.3.8 Other discounts

- (1) The discount is applicable only on the territory of Poland and after proving yourself with a respective Polish document entitling to a discount.
- (2) Soldiers of military police and military authorities who carry out official activities and other public transport activities shall be entitled to a 100 % discount.
- (3) Uniformed police officers accompanying detainees or transporting special consignments, patrol activities and providing assistance or assistance in the performance of state authorities shall be entitled to a 100 % discount.
- (4) Uniformed border guards officers are entitled to 100 % in the performance of official activities related to the protection of the state borders as well as during escorting detainees, patrol activities and activities related to the control of border movement.
- (5) Officers in the performance of official activities related to the prevention and combating illegal migration on communication routes of special international importance are entitled to a 100 % discount.
- (6) Customs officers in the performance of official audits referred to in Part V of the Law of 16 November 2016 on State Tax Administration (Civil Code No 1947).
- (7) Soldiers undergoing non-professional military service except for irregular and extraordinary services, as well as persons performing duties of this service in equivalent forms, are entitled to a 78 % discount. These include:
  - a) soldiers who advance basic military service, including a candidate service in the Prevention, Border Guard or State Protection Office;
  - b) soldiers undergoing a substitute service;
  - c) soldiers who serve as candidates for professional soldiers, i.e. they are educated at a higher military school (cadets), a military school (cadets), a professional military school (deer), an orchestra;
  - d) soldiers who undertake military activities (students of naval schools and naval academies) or military training;
  - e) soldiers who undergo military services.
- (8) Assistance or guardian accompanying a military or army invalid assigned to the first group of invalids shall be entitled to a 95 % discount.
- (9) Assistance or guardian accompanying a veteran, who is a military or army invalid assigned to the first group of invalids, shall be entitled to a 95 % discount.
- (10) Military and army invalids assigned to the first group of invalids or recognised as being incapable of working or self-exisitng (not related to military operations or military service) shall be entitled to a 78 % discount.
- (11) Veterans who are military or army invalids assigned to the first group of invalids or who are recognised as being incapable of working or self-existence, even if they are included in the first group of invalids (recognition of their inability to self-existence), are entitled to a 78 %.
- (12) Veterans who are military or army invalids assigned to the II or III group of invalids or



recognised as being totally or partially incapable of working shall be entitled to a 51 % discount.

- (13) Veterans, including members of the Military College for the Independence of Poland, and other authorized persons pensioners, invalids, and persons receiving severance or family allowances are entitled to a 51% discount.
- (14) Veterans who have suffered health injuries are entitled to a 37% discount.
- (15) Military and army invalids assigned to the II or III group of invalids or recognised as being totally or partially incapable of working shall be entitled to a 37 % discount.
- (16) Holders of "Karta Polaka" shall be entitled to a 37 % discount.
- (17) Parents or spouses of parents who are holders of "Karta Dużej Rodziny" (Karta Velké Rodiny) in the sense of law about Karcie Dużej Rodziny shall be entitled to a 37 % discount.

### 3.4 Discounts valid on the territory of other states

#### 3.4.1 Children and Juniors on the territory of other states

- (1) The fare for children and juniors is:
  - a) discount 25 % of the basic fare for carriage of passengers between the age of 6 to 17 (incl.), the discount is applicable for the rides in all the classes;
  - b) discount 50 % of the basic fare for carriage of passengers between the age of 0 to 5 (incl.), the discount is applicable for the rides in all the classes.
- (2) The discount is applicable only on the territory of Poland and after proving yourself with a respective Polish document entitling to a discount. Passengers between the age of 15 to 17 (incl.) are obliged to prove entitlement for a special fare with a valid identification card issued by public authority with the passenger's photo, name, surname and date of birth. The identification card may be issued by the operator after submitting the birth certificate and the photo of passport format for the manipulation fee of CZK 50.
- (3) It is a **so-called commercial discount** provided by the LE operator.
- (4) If the seat reserved for passengers with a child remains unoccupied after 15 minutes since the departure of the train from the departure station stated on the ticket, the supposed escort of the child is obliged to pay the price of the ticket up to the amount of the basic fare.

#### 3.4.2 Group and return ticket on the territory of other states

(1) On the territory of other states, **the group and return ticket discounts** are applicable according to the articles 3.1.7. and 3.1.8. of LE Tariff.

#### 3.4.3 Special fare on the territory of other states

(1) If the seat reserved for Passenger with a special fare remains unoccupied after 15 minutes since the departure of the vehicle from Departure Station stated on the ticket, the Passenger traveling with a common ticket is obliged to pay the price of the ticket up to the amount of the basic fare. If the extra charge for the unoccupied seat is not paid off, the entitlement for the reserved seat expires. For this purpose, the seat is not considered to be occupied if the Passenger places a part of the clothing or hand luggage on the seat.

#### 3.4.4 Interrail and Eurail

- (1) The Passenger is entitled to the discount of 100 % with Interrail or Eurail ticket.
- (2) Interrail and Eurail tickets are only valid for the train connections. It is not possible to use Interrail or Eurail ticket for the buses and minibuses. It is necessary to prove yourself with



the Pass and identification card.

- (2) The valid Pass for the 2<sup>nd</sup> Class can be used in the 2<sup>nd</sup> Class.
- (3) The valid Pass for the 1<sup>st</sup> Class can be also used in Business and Economy Plus Class.
- (4) It is necessary to make a reservation, there is no fee for the reservation. It is necessary to state the Interrail / Eurail ticket number.

# 5. Accepted Currencies

(1) In the Vehicle are accepted the following currencies: CZK, EUR and PLN under the condition that the chosen currency is national currency in one state, through which the train passes. In the Vehicle, it is possible to pay by a credit card depending on the specific technical conditions given the time and place.

# 6. Time Validity

(1) This Tariff is effective from July 1<sup>st</sup> 2022 and are valid till issuing a new Tariff.

## 7. Language Versions

(1) This tariff is published in Czech and English language versions. In case of divergence between the language versions, the Czech version shall prevail.
